English Language Proficiency can be met by the following criteria:

1. Country of Birth; OR
2. Australian Qualification Framework (AQF) equivalent secondary or tertiary education study; OR
3. An approved English Language Proficiency test.

All applicants will be assessed individually and will be contacted by the National Admissions Team if further documentation is required.
